EAs are federally licensed, and their authority extends across the United States. They are not limited by state jurisdiction unlike CPAs.

DEFINITION OF ENROLLED AGENT

An Enrolled Agent (EA) is a tax professional authorized by the U.S. Department of the Treasury to represent taxpayers before the Internal Revenue Service (IRS). EAs are federally licensed and are empowered to provide tax-related services, including tax preparation, representation during IRS audits, and offering tax planning advice. They undergo a rigorous examination process covering various aspects of tax law and must adhere to ethical standards. EAs often specialize in taxation and are valuable resources for individuals and businesses seeking expertise in navigating the complexities of the U.S. tax system.
